Dear Chair Collins, Vice Chair Murray, Chair Capito, Ranking Member Baldwin, Chairman Cassidy, Ranking Member Sanders, Chairman Cole, Ranking Member DeLauro, Chairman Aderholt, Chairman Walberg, and Ranking Member Scott:

We, the 104 undersigned organizations, write to express our deep concern regarding the cancellation of SEED (Supporting Effective Educator Development), TQP (Teacher Quality Partnership) and Teacher and School Leader Incentive Program (TSL) grants. These programs are a vital source of well-prepared educators for schools across our country. **We call on Congress to address these actions by instructing the Acting Secretary of Education to immediately reverse the cancellation of TQP, TSL, and SEED grants.**

Many of our communities are facing critical teacher shortages at a time when students are [about half a grade level behind](#) pre-pandemic achievement in reading and math. The TQP, SEED, and TSL programs help to provide high-quality, affordable, work-based pathways that expand the pool of qualified teachers, especially in teaching specialties where shortages are most acute including:

- Science
- Mathematics
- Career and technical education
- Early childhood education
- Special education
- English Language Learners

Because of a shortage of qualified teachers, schools in many communities are forced to rely on long-term substitutes, to hire unqualified individuals on emergency credentials, to increase class size, or even to reduce the number of days of instruction. Shortages are most acute in rural communities.

The SEED, TQP, and TSL programs address these challenges by ensuring schools are staffed with highly-trained professionals, improving student outcomes, and bolstering families' confidence in their school communities. Schools also face a shortage of principals, a need that can be addressed by all of these programs. In addition to directly addressing needs in the communities where they are located, these grants establish models of best practice that are replicated by educator preparation programs nationwide.

The Department has not released how many programs have been terminated, and the full impact is still being assessed, but we are aware that all SEED grants and most TQP grants have been canceled. Cancellations have affected colleges and universities — and their K-12 partners — in all parts of the country. Institutions of all types, from large research universities to small private colleges, to Historically Black Colleges and Universities, and alternative pathways have been affected. These cancellations have come in the middle of the academic year, and students who are only months away from becoming fully licensed teachers have lost scholarships and paid internships which made becoming a high-quality teacher possible. Many of these students have amassed student loans, and will be left without the teaching license they prepared for and need. For K-12 schools, the cancellations disrupt a pipeline of qualified educators needed to fill key vacancies next year and eliminate vital services, such as tutoring, that teacher candidates are providing this year.

The loss of these grants impacts the effectiveness of our teaching workforce. Many of the programs were designed to attract people from fields outside of education who could bring their expertise into the classroom. This is especially important in areas such as science, math, and career and technical education. Now, those individuals may no longer have access to the support and resources they need to transition into teaching, depriving students of valuable real-world knowledge and experience.

Below are a few examples of the impacts being felt across the country because of these grant cancellations:

- In Louisiana, a reported \$23 million investment in building a pipeline of quality teachers for high-need schools was canceled. Two TQP grants, one focused on recruiting local talent to serve in rural schools and another focused on implementing an apprenticeship-based degree and teacher certification model, were terminated. A SEED grant was poised to provide more than 550 teachers to New Orleans schools by 2025, and have hundreds of aspiring teachers enter the preparation pipeline.
- In Michigan, a TQP grant focused on addressing teacher shortages and another grant on literacy instruction were canceled.
- In Ohio, a TQP grant strengthened a network of PK-12 schools and one of the state's largest educator preparation programs. A proposed follow-up TQP grant planned to extend these partnerships for high impact tutoring with some of the highest need and most vulnerable populations in the region and to develop innovative school-based mentoring models to stem the high attrition rates among new teachers.
- In Tennessee, the cancellation of SEED grants has stopped work in rural Tennessee designed to enhance instructional leadership in STEM, literacy, and computational thinking. Planned professional development and training for 35 school leaders and 125 teachers has been cancelled impacting approximately 3,200 K-12 students in some of the state's most rural districts. These districts also have been severely impacted by catastrophic flooding and other damage caused by Hurricane Helene.

Research shows that the quality of preparation matters for teacher retention and student outcomes, which in turn impact our economic competitiveness and national security. Teachers who are prepared through high-quality programs, that include pre-service student teaching as well as integrated coursework, [are less than half as likely to leave](#) the profession as those who enter the profession through pathways that lack student teaching and other key elements of teacher preparation. Another [study in Texas](#) found that 9th grade students who had teachers prepared through high-quality programs gained more than two months of additional learning compared with students whose teachers did not have this preparation.

Instead of abruptly canceling grants, we should be doubling down on investments to ensure students have access to a highly qualified educator workforce. Congress, in a bipartisan manner, authorized and funded these programs. **We once again call on Congress to instruct the Acting Secretary of Education to immediately reverse the cancellation of TQP, TSL, and SEED grants.**

Thank you for your attention to this urgent issue. We look forward to your leadership in reversing the grant terminations and in finding solutions that will support our teachers and students.
