



HACU 2023-2024 State by State Comparison of Total Hispanic Undergraduate Enrollment

The State-by-State Comparison shows the total number of undergraduate students and the total number of Hispanic undergraduate students enrolled in each state. The proportion of Hispanic students relative to the total is listed as well. These numbers represent enrollment within the state and include both HSIs and Non-HSIs.

Please note, these numbers include enrollment at all Title-IV-eligible, non-profit, undergraduate-enrolling institutions in each state.

Data analysis was conducted by the HACU Office of Data and Research with the support of Dr. Rebecca Perdomo using National Center for Education Statistics, Integrated Postsecondary Education Data System (IPEDS), 2023-24 data.

HC: Headcount, total number of students enrolled including full-time and part-time students. Unlike with full-time equivalent (FTE), part-time students are counted individually.

UG: Undergraduate students

*This column indicates the total headcount of Hispanic students in the state relative to the total number of students enrolled.
